- 4. The programs have been granted accreditation for 3 years. Government Polytechnic Porbandar Near Jill Seva Sadan -1, Opposite Airport, NH 27, Porbandar 360577 Gujarat should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
